## **IRTA MEMBER BENEFITS**

Bob Campbell submitted the IRTA member benefits column to the WCIRTA Newsletter with expertise and pertinent information. With his retirement from the board, we will do some "pinch-hitting" with this issue of the Newsletter.

One of the benefits of being an IRTA member is that IRTA has partnered with AMBA (Association Member Benefits Advisors) to provide access to exceptional programs designed with retirees in mind.
